The World University Championships are prestigious international sporting events conducted under the auspices of the International University Sports Federation (FISU). Alternating with the Summer and Winter World University Games, they are organized every even-numbered year. Unlike the World University Games, the World University Championships are single sport events, the organization of which is delegated to a National University Sports Federation, a city, and local organizing committee.

UniUSA brings together the nation's most talented student-athletes, in global university-level competition organized by FISU, the governing body for university sport worldwide. With an impressive list of former UniUSA student-athletes going on to compete with distinction at Pan American and Olympic Games, as well as at the highest levels of professional sport, UniUSA provides a platform for future success. Participation selection and priority is given to individuals and teams that best represent the United States, both on and off the field.

THE TIMELINE

6 MONTHS PRIOR TO COMPETITION

- Contract signed and returned to BTI Events
- \$3,500 team deposit due

1 MONTH PRIOR TO COMPETITION

- Remaining balance due (if it exceeds 3,500 deposit)
- Flight Itinerary sent to BTI Events
